Church Covenant

MINUTES OF THE 81st ANNUAL MEETING APRIL 18, 2021

In compliance with the By-Laws of Grosse Pointe Congregational Church (Article X, B. Meetings) an Annual Meeting is required to be held during the first quarter of the year. The Board of Stewards, at their regularly scheduled meeting on March 3, 2021, scheduled the 81st Annual Meeting of Grosse Pointe Congregational Church for Sunday, April 18, 2021, following worship.

However, due to the Coronavirus (Covid-19) pandemic of 2020, the Governor of the State of Michigan, on March 23, 2020, issued an order that prohibited in-person gatherings or meetings. In compliance with that order, the Annual Meeting was held outside in the church parking lot, was available on Zoom and absentee ballots were used. A quorum was present which included members attending the meeting outside, members attending the meeting via Zoom and 13 absentee ballots, thus fulfilling the By-Law requirement of having a quorum (40 qualified voting members) present for the meeting.

Pastor Richard offered and opening prayer. Moderator Craig B. conducted the meeting.

A motion was made by Ron S., seconded by John B., and passed unanimously to approve the report of the minutes from last year.

The Moderator said the Stewards' reports appeared in the Annual Report and offered the Stewards the opportunity to speak to their published reports: none felt this was necessary.

Craig reported on the Welcome All Building Project (WABP). He said the elevator was awaiting inspection, the reception desk was nearing completion, the ceiling tiles will be installed and the outside painting begun.

Craig discussed the pending lease with a learning organization, The Giving Tree, for the rental of our second floor space. Income from the lease is estimated to be \$30,000 per year plus they will pay 60% of the utility bills and provide janitorial service for the entire building.

A motion was made by Ron S. and seconded by Kay V. to affirm the Board of Stewards slate for 2021-2022 as follows:

- Petersen Decker, Moderator
- Ed Priebe, Vice Moderator
- Paul Fugate, Steward of Worship and Music
- Don Nave, Steward of Christian Education

There being no objection, the Board of Stewards slate was approved.

John B. thanked the Finance Committee for all their work during the past year. He presented both a Balance Sheet as of December 31, 2020 and an Operating Budget for 2021 and said that the WABP will be added to the Balance Sheet in 2021. He noted that, going forward, we need to increase both membership and contributions. He said that Steeple Accounting was hired to close the books for 2020 and will continue to provide services to GPCC on a quarterly basis. He also explained the replacement of our investment manager, Sigma Investments, with Royal Bank of Canada (RBC) and the concomitant transfer of funds to RBC. He thanked Craig B. and Cathy L. for their assistance in securing two Payroll Protection Plan (PPP) payments through Chase Bank. John accompanied the 2021 General Operating Fund Budged with written notes which are part of the Annual Report.

There being no objection to our discussion of the 2021 General Operating Fund Budget, a motion was made by Ed P., seconded by Ron S., and passed unanimously to accept the 2021 General Operating Fund Budged as presented.

The results of the absentee ballot voting were

- o 13 "yes" votes affirming the Board of Stewards
- o 10 "yes" votes for the General Operating Fund Budget
- o 3 abstaining to vote for the General Operating Fund Budget

Craig Baetz welcomed the new Moderator, Petersen D., to the Board. Petersen thanked Craig and Pastor Richard for all their working during the past, as well as the congregation for all their support. He noted that the Board of Stewards has full complement of Stewards going forward and said that Craig B. will continue to monitor the WABP. He also announced the Aaron T. has been appointed to the Pastoral Relations Committee for a three year term ending in 2024.

Pastor Richard thanked everyone and offered and closing prayer.

2021 Pastor's Report

Friends,

In last year's annual report, I gave a historical overview of what we had experienced during COVID-19 so that future generations would pick up a copy of this annual report and see what we had to do to survive: wear masks in public and inside buildings, social distance so we could hold worship, wear gloves and always have a Clorox Wipe prepared to wash every surface we were going to touch. We had to hold our worship services outside and over Zoom, a digital video streaming service.

Three months after our Annual Meeting, and we were ready to return to in-person worship indoors, when the Grosse Pointes suffered a "100-year flood" which utterly destroyed everything in the basement. The art gallery wooden floors were trashed as was the stage – which was original to the church building and used to sit roughly three feet above the floor.

Heartbroken, many wondered if we would recover.

Since you are reading this letter in 2022, or many years later, you can see we not only recovered, we came roaring back to life. In the process of returning to life, we examined the ministries we had to offer and re-imagined what we could do with the church building we have. In addition, taking a spiritual gift inventory, we gained new friends and members who love our church and share the image of what we have to offer.

Looking forward to 2022 and 2023, we discussed exciting ministries which would involve recreating the Fellowship Hall and kitchen so we could have dinner theatres with our newly launching Theatre Ministry. This vision was cast while exploring what the Fellowship Hall and Kitchen could look like. Seven months after the flood, the stage had volunteers who would rebuild it and the kitchen began to take shape. Incredibly, our visions were becoming a reality.

The Women's Fellowship also shared their incredible ideas and visions, as they met to discuss with me how to create an interactive and wonderful ministry which includes both members and our community in a creative and fun atmosphere in the Fellowship Hall as we utilize a newly built a fully barrier-free accessible stage.

Friends, I am eager for the lower and upper levels to reopen to what God is enabling us to do and with our new spaces, it will be incredible what our ministries will become as we keep following God, together.

Many, many, kudos to Craig B. and John B. for getting us over the hump so that the new addition was completed – during COVID, no less.

Thank you, John B., for helping bring so many persons together so that we could pray together and see a vision which is taking fruition in the lower level as we repair the building.

Thank you, Dr. Ron and Diane S., Darlene S., Skip and Martha S., Dick H. and Kay V., and John C. for having a vision to replace the drapes in the Sanctuary.

Thank you, members of the Women's Fellowship, for your assistance and willingness to dream with me new ways that we can hold fundraisers at church. I am looking forward to our first indoor play on June 4.

It is incredible what God is doing and I am ecstatic that so many of you have raised your hand and volunteered to help us launch the church into unchartered territory. Especially as we keep getting knocked down: COVID-19, flood with very unhealthy water, then the death of our wonderful Music Director, Tamm L.W. It has been a heart-breaking two years which we have endured, together. Yet, together with God, we keep discovering through the heartache and pain how we can rely on each other to discover God's grace which informs us: "we are not forsaken." As the prophet Isaiah suggests, God is near and invites us to rest our souls with the knowledge that we can keep succeeding. I understand that this concept seems foreign. Still, with faith in the impossible and faith in Christ who declared we are his and we are blessed by God; We will rise in faith. The church is ready for a rebirth, and GPCC is going to witness new things and things undreamt.

Moderator's Annual Report

To the Congregation and Friends of Grosse Pointe Congregational Church, on behalf of the Board of Stewards:

The **2021** challenges and obstacles which our Church is still successfully working through were unprecedented. Notwithstanding constant **Covid setbacks**, remote worship outdoors in the cold and heat, distancing of all sorts, and labor and material shortages, we **continued to completion a seven-figure building construction project** encompassing the first-floor entryway, portico, parking area, new elevator/ADA compliancy, hallways, reception area, lighting, bathrooms, Pastor's study, the office, and stairways.

But unexpectedly, the **summer of 2021** brought with it a few feet of basement **sewerage back-up,** immediately followed by additional thunderstorm **flooding.** All told, the Church building incurred **significant losses** to:

Add the nearby **parsonage's similar major damage** and accompanying months without heat, water, and repairs.

And **endless meetings** among ourselves and with the insurance carrier, adjusters, city officials, inspectors, contractors, restoration companies, storage and container suppliers, lost tenants, accountants, lawyers, and United Church of Christ officials.

Through it all, we as a people of God arose above crisis mode with heavenly guidance and vigor. We steadfastly committed to sustaining and expanding without interruption our Godly RISE mission to Reach out, Inspire others, Serve, and Embrace diversity. We called upon our Pastor, staff, committees, other volunteers, and the Congregation as a whole to take extraordinary and drastic and immediate measures to counter one unexpected circumstance after another.

Along the way we as a Church and a family and a community suffered personal losses.

But without flinching, we have taken on every new and unforeseen burden with indescribable God-inspired faith and with dignity. Unselfishly and without complaint. Never once letting our guard down or momentum diminish, we acknowledge that God is always with us and guiding us. Through it all we maintained the vibrancy and the breadth and depth of our calling to follow the Bible's tenets and to advance discipleship to Jesus in service to others. We

drew from the Holy Spirit within and through prayer for foresight and energy and blessing. We continued sacrificing and giving of our time, talent, and treasure. And it was enough.

We are all too aware of what we had to do. We had to take unparalleled and empowering initiative to reclaim and sustain and expand what we as a Church do. We are delivering. Praise God.

In addition to the major construction and re-construction to the Church building and parsonage as well as working through Covid restrictions, the Church's **other 2021 accomplishments include:**

- Flexible remote and in-person attendance
- "Welcome Home" return to sanctuary services during Covid
- Website and printed literature enhancement; listening access to services and past sermons internationally
- New air purification system
- Newly acquired computer equipment
- New FM transmitter and cameras for services broadcasting
- Whosoever Ministries support
- Jewish Council support
- Annual stewardship campaign
- New legal counsel
- And so many others highlighted in this report

Our debt of gratitude to our Pastor and staff and a cadre of special volunteers, along with the support and patience among the Congregation, cannot be adequately measured or expressed. We know, however, that we would not be even close to where we now are without every one of them. And in particular it is a privilege to recognize and extend my personal and heartfelt appreciation to the Board of Stewards for so capably leading and with whom I have had the pleasure of serving:

The Steward of Worship oversees several functions at the church which include overseeing the Ushers, Music selection for services, ensuring four individuals are available each month to serve Communion, and Scripture Readers are assigned for every Sunday service.

COVID-19 cancelled many events, and still, sadly, does. Then we experienced the flood this past June, which broke the art gallery, fellowship hall and stage. However, through the grace and mercy of God, we are rebuilding and are nearly restored.

Like Naaman (2 Kings 5) who had to be washed in a filthy river so he could emerge clean and pure, so our ministries have been washed and new opportunities have arisen.

Out of the destruction I was able to assist Pastor Richard to launch a Theatre Ministry, which focuses on sharing the Word of God through performance art. Our performances will offer a unique opportunity as we will offer an intimate space where persons can experience our Christian discipleship. I am reminded of the words from St. Francis of Assisi who said, "Preach the Gospel, always.... use words when necessary." This means we will have secular and religious plays, yet there will always be an opportunity for guests to see Christ in us during intermission and at the afterglow. The Women's Fellowship also volunteered to utilize the event as their fundraiser as they assist with the play and discussing this with Sue and Jack L. and their desire to help the Women's Fellowship and the Church, there will be some art selections available from the estate of Tamm L. W.

The Deaf Ministry is hopeful to be back at church soon. Many of the student interpreters were directed not to go out in public places. UGH. However, I am sure many students will be with us very soon.

Pastoral Relations Committee 2021

The Pastoral Relations Committee is a standing committee that seeks to support and maintain an open and healthy relationship between the pastor, the church and members of the congregation. The committee acts as an advisory group, sharing the hopes, dreams and expectations and concerns of the congregation and serves to support the pastor's leadership. Our meetings were in person, wearing masks inside the church building. 2021 was a year like no other and the Pastoral Relations Committee strived to meet the above stated objectives. At committee meetings Pastor Richard was able to express feelings, concerns, ideas, and frustrations; committee members could do likewise.

The COVID virus had already derailed the course of the church in March of 2020, moving worship services to the parking lot, or to our TV's for Zoom at home. Then on June 25, 2021, an epic heavy rainfall caused water and sewage to critically damage the entire lower floor of the church building. The Parsonage experienced the same sewage flood in its basement, destroying some of the Pastor's personal treasures.

NO VACATION IN 2021. With just one secretary and no sexton, Pastor Richard took on a long list of jobs including many secretarial and janitorial duties, while still fulfilling all obligations expected of a clergyman. This was made more difficult with the constant presence of basement repair workers. He dealt with loss and illness among his own family members during this year as well. In early December, our much-loved young choir director, Tamm Whitty, died unexpectedly.

Though tremendous loss changed the direction of some familiar programming, much has survived and continued. Congregants have stepped up. Boards and committees have done their work. Pastor Richard has shown reason and leadership. He encouraged optimism at a time when pessimism was likely. He continues to teach that God is good and faith in Him inspires us to achieve the "New Beginnings", so this church and the communities that we serve will be better than ever.
